Re: Notice and Demand Letter, Honorable A.G. Merrick Garland and F.B.I. Director Christopher Wray

Dear Chief Counsel Zornberg,

As counsel to Mayor Adams, I write to you in regard to status, as the *Notice and Demand*, which has not been opposed and has since gone unanswered, requires the immediate response of the Mayor's Office. In light of the connection between a number of arguably preventable disruptive events in New York City and inaction on the part of the Mayor's Office, Honorable Merrick Garland and Director Christopher Wray, a sincere expectation of contact from the Mayor's Office exists as to the measures, which your office will proactively undertake to remove the inflammatory and potentially riot-inciting *BLACK LIVES MATTER* "insignia" from 725 5th Ave, New York, New York.

The *Notice and Demand* referred to "*BLM – American Hamas*", by Robert J. Antonellis, which details the long-standing and tightly-woven interconnections among and through *Harvard Hamas*, the *Weather Underground* and *BLM*, which are known Pro-Islamic Hate America First groups. With regard to the signage, these shadowy groups and their associates were seemingly operating from and influenced by the office of then-Mayor Bill DeBlasio a.k.a. Warren Wilhelm. As such, the *BLM INSIGNIA* in and of itself is incendiary with its origins directly linked to Bill DeBlasio.

When news broke that New York City's Mayor Adams' Office stood in support of international law and the State of Israel's international right to defend itself, New Yorkers took Mayor Adams at his word when he stated the measures to protect Jewish residents and to fight anti-Semitism within New York City and abroad. As we know, *Hamas* and *BLM* protesters selected Veterans Day, 11/11/23, to express their anti-Semitic sentiments by attacking unsuspecting holiday shoppers and travelers in, of all places, Grand Central Station. In this case, even New York's Finest, the best-trained officers in the world, were forced to "shelter in place" and "hide inside" Grand Central Station, leaving innocent citizens to fend for themselves against what must have appeared to have been a mob of zombies.

The violence of that shocking attack stands in sharp contrast to a peaceful protest that took place at the same location, Grand Central Station, shortly before, held by a group calling itself "*Jewish Voice for Peace*", which waged a "sit in" calling for a ceasefire in *Gaza*; but, did so without damaging New York's most historic transportation hub nor assaulting a single traveler.

To conclude, New York City's Mayor's office should also be on notice that former Mayor Bill DeBlasio painted that *BLM INSIGNIA* on historic Fifth Avenue, either in his personal capacity, not as Mayor, or otherwise. Thus, he and Sharpton have a potential future legal matter to attend to.

Additionally, an inverted, distorted, subversive American flag displayed on Bay Street in Staten Island is in violation of 4 USC Ch. 1: THE FLAG.

To conclude, as you are counsel for *Mayor Adams*, will you advise your office to simply accept a Hamas New York and a future terror attack before stopping this invasion of vitriol and venom we're seeing directed against our Judeo-Christian Civilization on which New York City is built?

The time is now for Mayor Adams to order immediate removal of the trigger and catalyst for conflict on 5th Avenue.
